The extended 2018 Farm Bill limits total CRP enrollment to 27 million acres. Current enrollment is approximately 24.7 million acres. Contracts totaling 482,527 acres from all signup types are scheduled to expire on September 30, 2024.

**General CRP:**

General CRP signup 62 was held from March 4, 2024, through March 29, 2024. Land not currently enrolled in CRP was eligible to be offered for enrollment during general CRP signup 62. In addition, CRP participants with a contract scheduled to expire on September 30, 2024, were eligible submit an offer for land enrolled under contract. Offers accepted will have a contract beginning on October 1, 2024. We are currently waiting for the National Office to release the accepted/rejected list.

The CRP Expiration Letter states that sign-up period for Grassland CRP is April 29, 2024, to May 24, 2024. The National Office will be providing additional information in the near future.

**Continuous CRP:**

**Notice CRP-1016:**

**A New Signup Number and Dates**

Beginning January 12, 2024, County Offices may begin accepting offers for:

- new land under continuous signup
- new land plus land scheduled to expire on September 30, 2024
- land scheduled to expire on September 30, 2024.

For program administration purposes, the continuous CRP signup number will change from signup 59 to signup 61 effective October 1, 2023, for program years 2024 and 2025.

The deadline for producers to submit a new offer, an offer for re-enrolled land, or a combination of new and re-enrolled land is COB **July 31, 2024**, to have an October 1, 2024, contract start date.

**Notice CRP-1025:**

**A Batching of Non-CREP Continuous CRP Offers After March 15, 2024**

All continuous CRP Signup 61 Offers received after March 15, 2024, will be batched according to the following table. A future notice will announce additional batching periods after May 10<sup>th</sup>.

**Exception:** County Offices will continue to accept and process offers for approved CREP agreements as CREP offers are not subject to batching periods.

**MN March Batch Results:** 1457 offers were accepted, consisting of 20,827 acres.

The following are the FY 2024 continuous CRP deadlines.

<b>Date</b>	<b>Action</b>
July 31, 2024	Deadline for producers to submit an offer for new or re-enrolled land or combination of new and re-enrolled land for continuous CRP signup 61.
August 7, 2024	Deadline for producers to request a conservation plan from NRCS. County Office deadline to enter the status in COLS as “Submit for Plan” for continuous CRP signup 61.  <b>Note:</b> FSA must provide offers to NRCS within 5 workdays of receiving the submitted offer from the producer.
September 6, 2024	Deadline for NRCS/TSP to complete the conservation plan, sign, and obtain signatures of all signatories on CRP-1, and return the conservation plan to FSA
September 30, 2024	Deadline for COC or CED to approve CRP-1’s and load CRP-1 approvals in COLS.
