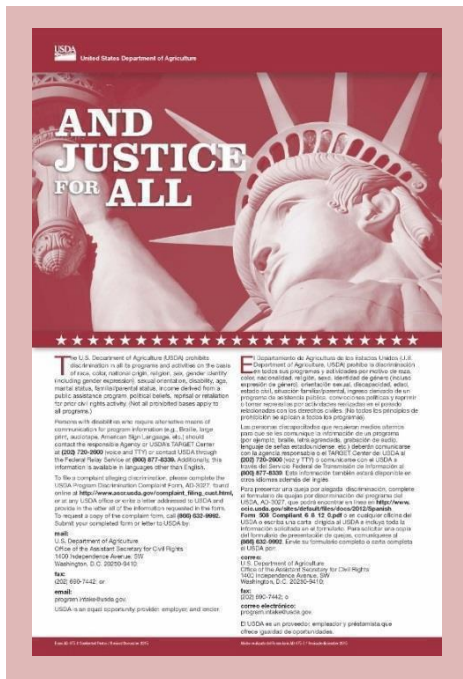

Non-Discrimination Statement
