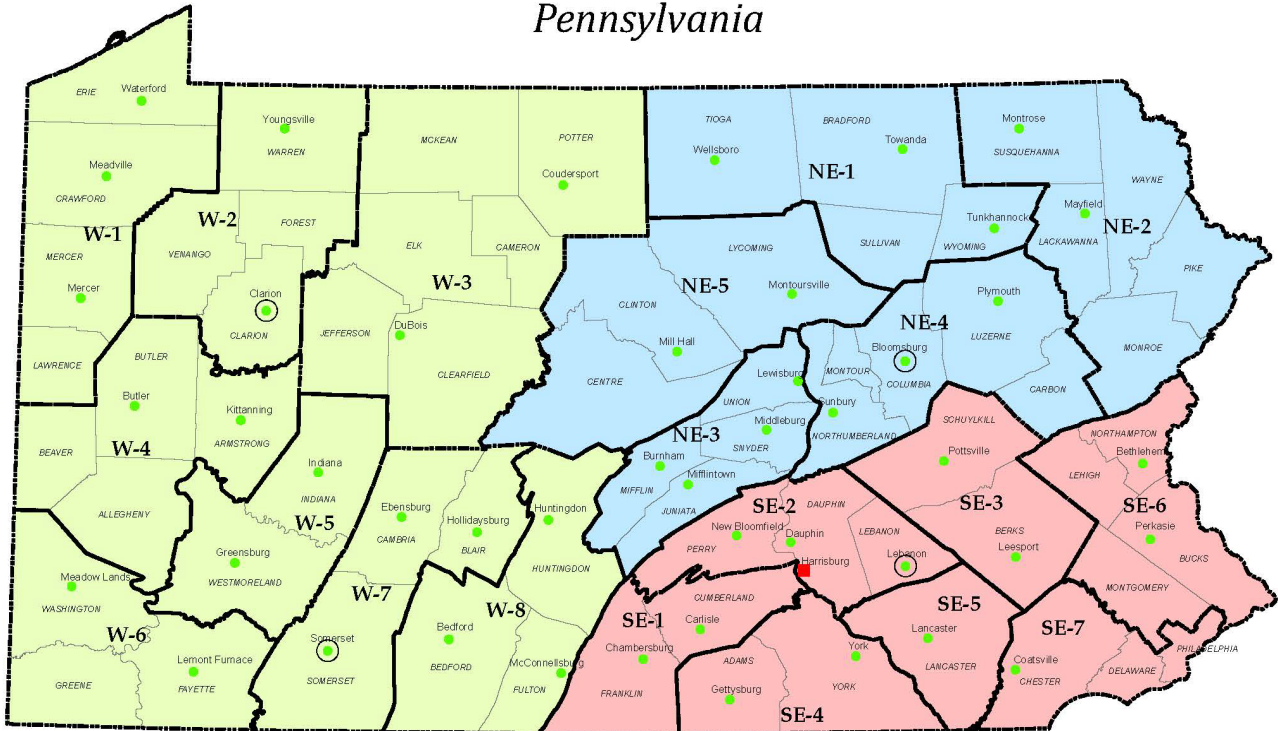

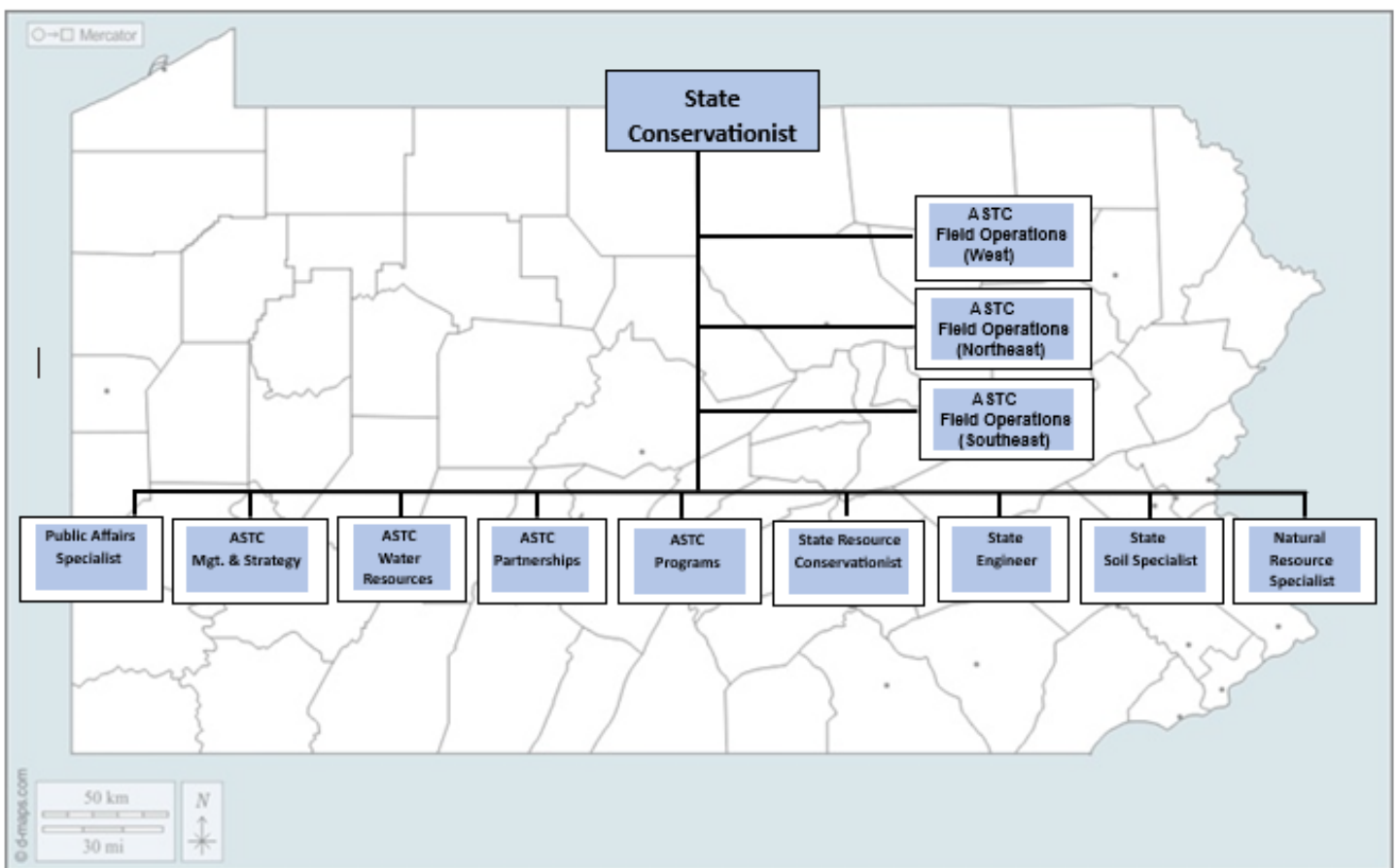

# Pennsylvania NRCS Organizational Chart

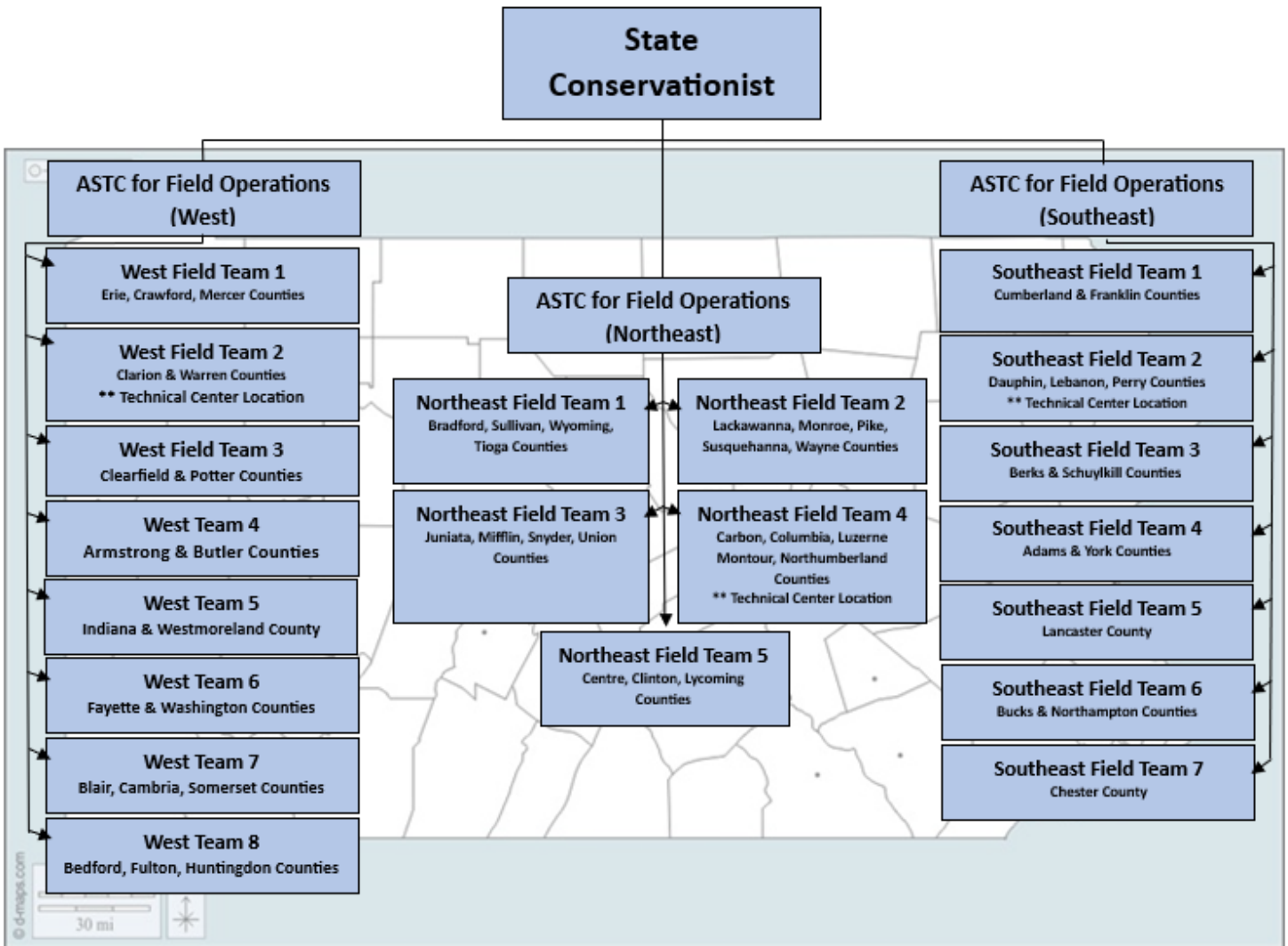
