

RANSOM County Eligible Practice List

Contract holders certifying as a limited resource and beginning farmers or ranchers, and socially disadvantaged are eligible for a payment schedule which is 25 percent higher than typical financial assistance.

Existing and relocated animal feeding operations are eligible for up to \$175,000 of financial assistance to implement practices required for the proper design, implementation, and management of the animal waste system. New animal feeding operations are eligible for up to \$100,000. Contract holders certifying as a limited resource and beginning farmers or ranchers, and socially disadvantaged are eligible for up to \$220,000 for existing and \$125,000 for new ag waste systems.

- The payment limitation includes payments for structural and management incentive practices. The payment limitation does not include Practice Code 102 – CNMP.

Practices associated with irrigation conversions, including structural and management, will be limited to \$85,000 per operating unit. Contract holders certifying as a limited resource and beginning farmers or ranchers, and socially disadvantaged are eligible for up to \$107,000.

If local resource concerns merit the implementation of a conservation practice not considered a State eligible practice, the Local Work Group (LWG) may submit a request to the State Conservationist. Requests must justify how the practice will benefit National, State, and local resource concerns. Requests shall include payment method and recommend proposed costs so we can show justification for the cost of the practice or treatment (labor, material, foregone income, installation, mobilization)
