16. Water - Excessive Nutrients and Organics in Surface Water: Offer includes planned treatment to exclude livestock from an existing waterbody	30 Point(s)

Water - Excessive Nutrients and Organics in Surface Water: Offer includes planned treatment to improve the efficiency of storage/handling of animal waste by implementing any of the following practices: composting facility (313); waste storage facility (317), or Animal Mortality Facility (316).	20 Point(s)
