

Minnesota Grazing Lands Facts

- GLCA is an important partner with the NRCS, state and local agencies. As they provide valuable technical and educational assistance to the land owner and the producer.
- Grazing lands comprises about 4.5% or 2.5 million acres of land in Minnesota.
- Grazing lands provide the principal source of forage for domestic livestock in Minnesota.
- Grazing lands provide essential habitat and foraging areas for many kinds of wildlife, including both game and non-game species.
- Grazing lands provide watershed protection and recharge the water supply.
- Grazing lands in Minnesota are comprised of improved pastureland, rangeland, and naturalized areas. Vegetation ranges from cool season introduced species on pastureland to native remnant prairies on rangeland. With a mix of cool introduced species, and native remnant prairies, accounting for naturalized areas.
- Grazing with beef cattle and dairy cows are the primary use of Minnesota grazing lands. Forage production is the basic goal of the rancher/farmer. Maintenance or improvement of grazing lands is just as important as livestock husbandry.


