



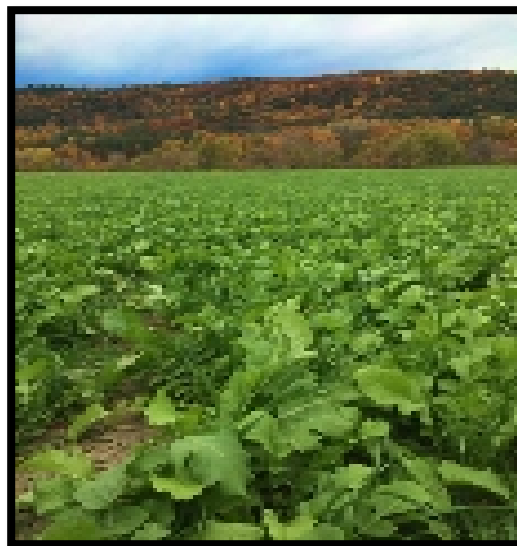

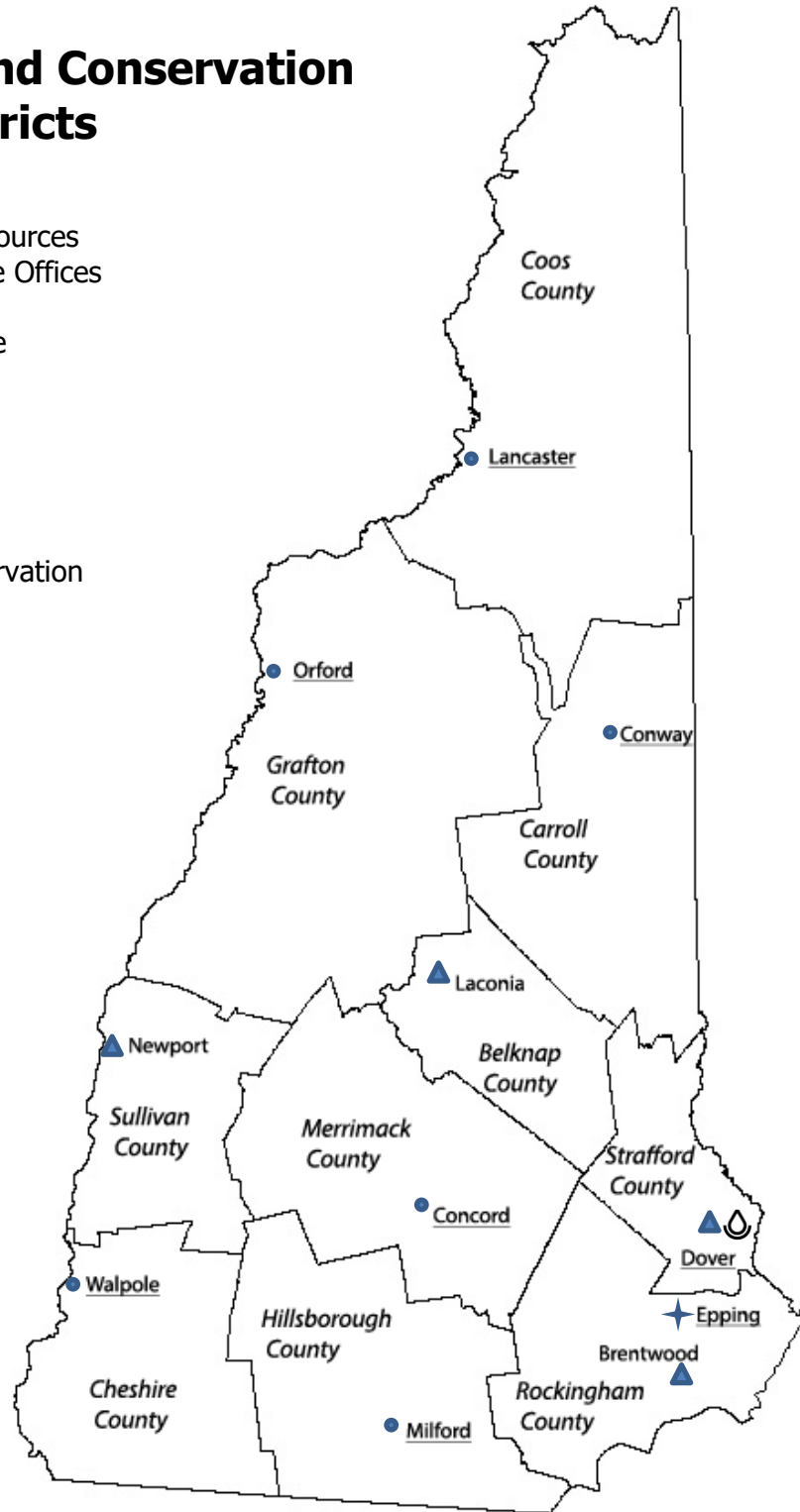

We will provide leadership and professional service in partnership with Conservation Districts and others to assist the public to preserve, protect and sustain natural resources.

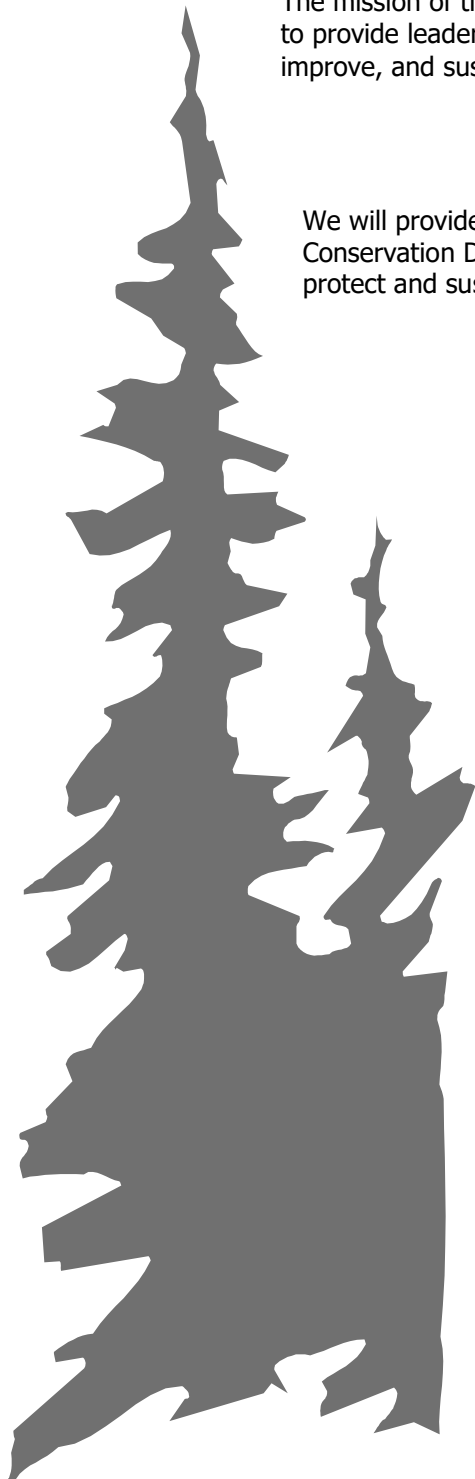
We will accomplish this vision by:
