## Conservation Partners Request for Proposals Spring 2013

The National Fish and Wildlife Foundation (NFWF) and USDA Natural Resources Conservation Service (NRCS) have forged a partnership to provide grants on a competitive basis to support field biologists and other habitat professionals (botanists, ecologists, foresters, etc.) working with NRCS field offices in providing technical assistance to farmers, ranchers, foresters, and other private landowners to optimize conservation on private lands. Funds may also be used for outreach, monitoring, evaluation, and capacity building.

# 7 Generations of Farmers

## Building a Sustainable Farm

Lifelong farmers Francis Jordan and his son Vic Jordan have been putting conservation on the ground for years. Since 1841, seven generations of the Jordan family have been farming their land, and today Jordan Planting Company II is one of the largest farming operations in Richland and Morehouse Parishes.

Their love for the land is evident in this father-son operation. Both Francis and Vic started working on the farm at an early age, and Francis remembers growing his first cotton crop in 1955 after returning from the service. Today, the Jordans plant

corn, soybeans, wheat, rice, and peanuts, and they have 140 Angus cattle on 300 acres of pasture.

They have been working with the USDA Natural Resources Conservation Service (NRCS) for years and have implemented a suite of conservation

practices on their 3,500 acre farming operation, including irrigation land leveling, irrigation pipeline, grade stabilization structures, forage and biomass planting, livestock pipeline, fence, watering facility, heavy use area pads, and nutrient management.

**In 2011, the Jordans implemented Louisiana NRCS’ first Spill Prevention, Control, and Countermeasure (SPCC) facility on their farm in Richland Parish.**

This facility, also known as an Agricultural Secondary Containment Facility, is designed to minimize the risk of on-farm oil products from accidentally being released into ground and surface waters. In order to help offset the cost, the Jordans were able to receive **Environmental Quality Incentive Program (EQIP)** funding through a pilot program to assist eligible producers in complying with the Environmental Protection Agency’s (EPA) Oil Pollution Prevention Regulations.



“We knew this (SPCC) was going to be mandated by the EPA and with just coming out of a good corn crop year, we thought it was a good opportunity to get it done,” said Vic Jordan, referring to the costliness of building the facility.

The Jordans have an on-farm fuel containment facility that not only meets NRCS specifications but EPA regulations as well. They completed an SPCC Plan that was created by a Technical Service Provider (TSP) and trained their farm employees.

# Applications Being Accepted For NRCS Pilot Program to Help Farmers and Ranchers Comply with On-Farm Oil Spill Regulations

## Spill Prevention, Control, and Countermeasure Pilot Program

### First Application Evaluation Period for FY 2013 Funding Ends April 19, 2013

The U.S. Department of Agriculture's Natural Resources Conservation Service Oil Spill Prevention, Control, and Countermeasure (SPCC) Pilot program is being offered to help agricultural producers comply with revised regulations by the Environmental Protection Agency (EPA). The SPCC program is intended to prevent and mitigate fuel and oil spills on agricultural operations. The pilot program is funded through the Environmental Quality Incentives Program (EQIP).

In order to be considered in the first SPCC Pilot application evaluation period for fiscal year 2013, interested agricultural producers are encouraged to visit their local NRCS office as soon as possible. The first application evaluation period for fiscal year 2013 SPCC funding ends April 19, 2013.

NRCS has developed an SPCC Conservation Activity Plan to assist farming operations that exceed 10,000 gallons of above-ground storage capacity. Those facilities with less than 10,000 gallons but more than 1,320 gallons of above-ground storage capacity should take advantage of the self-certification template provided by EPA. NRCS has also developed a practice standard to assist producers who wish to implement elements of an approved SPCC plan and comply with the SPCC rule.

The Environmental Quality Incentives Program (EQIP) is authorized by the Farm Bill to assist eligible landowners plan and implement conservation practices that address natural resource concerns and for opportunities to improve soil, water, plant, animal, air, and related resources on agricultural land and non-industrial private forestland. In addition, EQIP also helps producers meet Federal, State, Tribal and local environmental regulations.

### The SPCC Rule and How NRCS Helps Farmers

The Environmental Protection Agency Spill Prevention, Control, and Countermeasure (SPCC) rule requires farms and other facilities to develop, maintain, and implement an oil spill prevention plan, called an SPCC Plan. These plans help farms prevent oil spill, as well as control a spill, should one occur. NRCS has developed an SPCC Conservation Activity Plan to assist farming operations that exceed 10,000 gallons of above-ground storage capacity. NRCS has also developed a practice standard to assist producers who wish to implement elements of an approved SPCC plan and comply with the SPCC rule. NRCS is providing SPCC technical assistance to farmers through Technical Service Providers who are licensed, registered engineers. The Wetlands Reserve Program provides financial incentives to landowners to restore their land to its natural wetland condition with an emphasis on enhancing wildlife habitats and environmental benefits.

The Wetlands Reserve Program is a national program authorized by the Farm Bill to assist eligible landowners restore, create, protect, and enhance wetlands on their property. Participation in this program is voluntary, and restoration is accomplished in an environmentally safe, cost-effective manner.
