Whereas, the Watershed Work Plan Agreement for the Mill Creek Watershed, State of Texas, executed by the Kaufman-Van Zandt Soil and Water Conservation District, the Neches-Sabine Soil and Water Conservation District, the City of Canton, Texas, and the Van Zandt County Commissioners Court named therein and the Service became effective on the first day of April, 1969; and

Whereas, in order to carry out the watershed work plan for said watershed, it has become necessary to modify the said Watershed Work Plan Agreement; and

Whereas, Mill Creek Watershed now is entirely within the Kaufman-Van Zandt Soil and Water Conservation District because of changes in the boundaries of said District; and

Whereas, the Kaufman-Van Zandt Soil and Water Conservation District agreed to accept all responsibilities theretofore assumed by the Neches-Sabine Soil and Water Conservation District; and

Therefore, the Neches-Sabine Soil and Water Conservation District is hereby relieved of its commitments and responsibilities and ceases to be a co-sponsor effective as of the date this Supplemental Watershed Work Plan Agreement is executed. All other provisions of the Watershed Work Plan Agreement remain unchanged.
