
The GPR unit that is owned and operated by the soil staff in New York is presently inoperable because of a malfunctioning graphic recorder. I inquired with the U.S. Geological Survey, Branch of Geophysical Applications and Support as to the availability of any older, excess GPR units that were not being used. I was informed that possibly three units were available.

On 13 July 2000, I traveled to Storrs, Connecticut, to pick-up two SIR System-8 and one SIR System-3 radar units from the U.S. Geological Survey, Branch of Geophysical Applications and Support. These units were no longer being used and the Geological Survey wished to remove them from its inventory. Some of the components are in bad shape. However, the transfer was conducted under the condition that USDA-NRCS takes "all or nothing." I signed for the equipment (see attachment A). Later that day, I inventoried, tested, and cleaned the components.

Two of the graphic recorders and two control units are in working condition. None of the three tape recorders are functional. The SIR System-3 is presently inoperable, as paper will not advance through the graphic recorder (this malfunction can easily be repaired). However, if repaired, the SIR System-3 is in excellent condition and may represent the best and most lasting part of this exchange.

On 17 July, I transferred the equipment to Ed Stein at the field office in Middletown, New York. Also transferred were twenty-two rolls of graphic paper and an equal number of stylus belts. I request, that Ed Stein review, and if acceptable, sign and return to me the enclosed inventory list.
