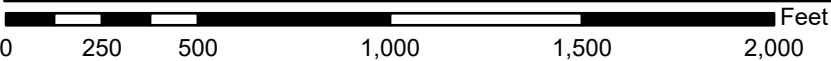
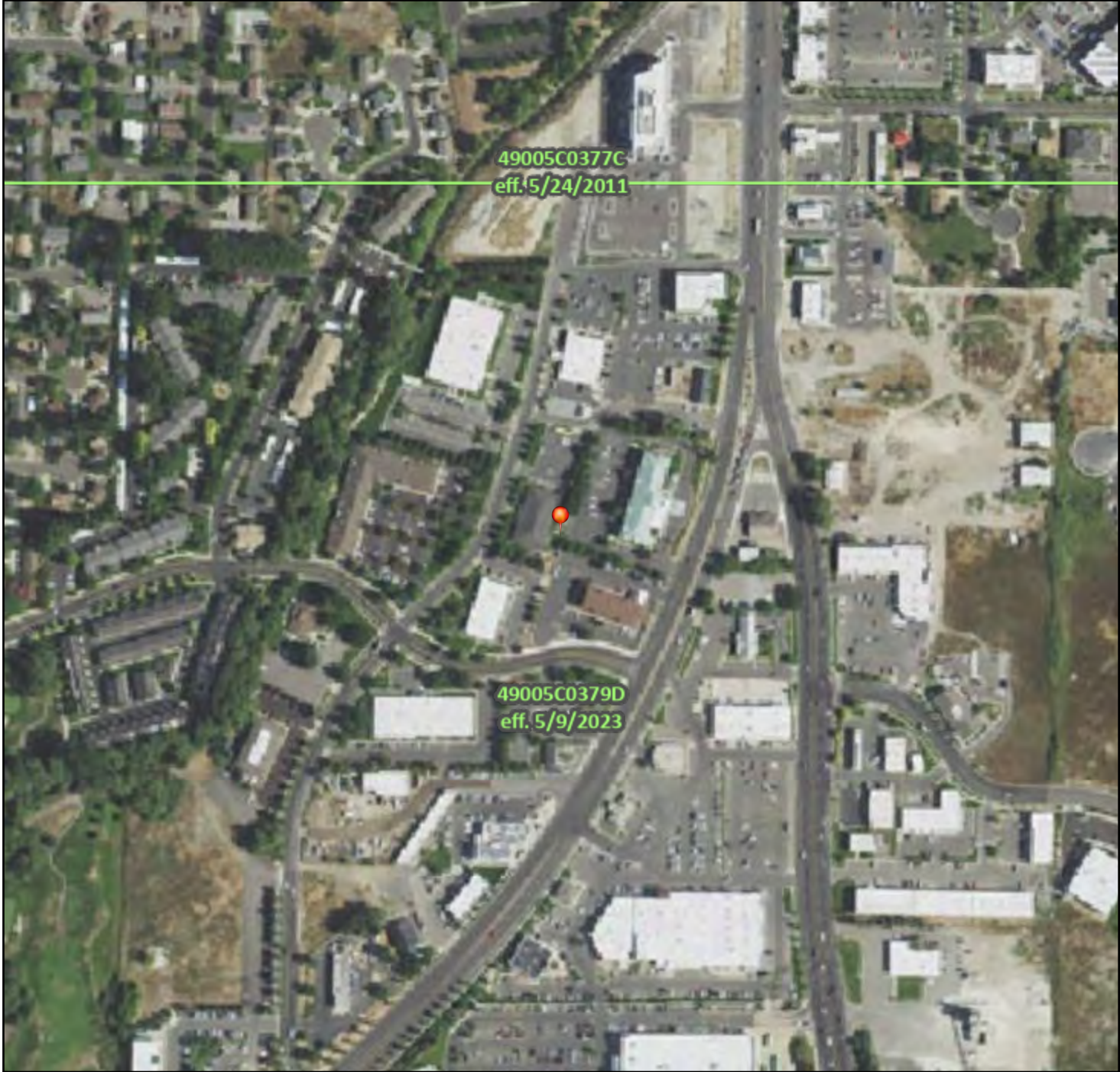
Map 2 – UDEQ Hazardous Materials Map
