The EA states that "no active nest belonging to raptors or migratory bird species" were found in the project area, but that the project area could provided "perching or foraging habitat" (p.64). However, the nest surveys were done in the late summer months (p.33). Since for many species nesting occurs in spring and early summer, such surveys are unlikely to detect nests. The project area certainly provides suitable habitat for nesting, and one person even commented that ows nest on the canal by her house every year (page E-45). You indicated that the area would be checked for nests again prior to vegetation removal, but that does not address the potential effects on bird populations due to "permanent removal of riparian vegetation" (p.04) that currently provides suitable nesting habitat are variety of migratory selection and visual resources/scenic beauty. The advantage of additional width so that more people can walk side by side is far outweighed by the loss of green space. 2. The amount of margin beyond the pathway that is maintained as grass should be minimized. Not only is it an ongoing maintenance issue, but again, this green space is mostly for walking and enjoying the nature, not throwing frisbees or playing on a lawn. 3. Benches with firm backs are good; picnic tables would take up too much space, and would encourage people to eat there. While that is not currently prohibited, I don't think it should be encouraged. I foresee a trash problem. 4.A brief survey of the native species that "volunteered" to grow there should be maintained, and those species, if possible, be retained or replanted after construction. There are people in the community that would be glad of the opportunity to help. 5. While a native mix of pollinator plants is a good idea, again, the naturally occurring pollinator plants should be retained and encouraged. There are people in the community that would be glad of the opportunity to help. 6. Invasive Russian olive should be cut back. There are people in the community that would be glad of the opportunity to help. 7. It is possible that the amounts of water discussed will be insufficient for the cottonwood trees, but I do not know. We will find out.
