Why Urban Farming?



Conservation Practice Standard and guidance document review process

- The 2018 Farm Bill required that all NRCS conservation practice standards (CPS) be reviewed at a national level and reviewed/adopted by the states.
- At the national level CPSs are updated and put through the federal register process.
- Once the federal register process is complete NRCS releases the standards for the state to review.
- At the State level NRCS can make the CPS more "strict" than the national CPS but cannot make it more lenient.

CPS and guidance document review process continued

- NRCS FL has determined that the top 15 most applied CPS in the state will be sent to all members of the STAC.
- NRCS Field and Area office staff will have the same time and opportunity for review.
- STAC members will have 30 days to provide comments and feedback on the CPS and associated documents.
- Once the 30 days is up the designated technical lead for that practice will compile comments and evaluate if they can or should be incorporated.
- Once review is finalized and updates are made the documents are loaded onto Section 4 of the Field Office Technical Guide.

Joint Chiefs' Landscape Restoration Partnership

- Project Proposals are developed through a collaborative process between NRCS, Forest Service and partners.
- Proposal application period is currently open until August 5, 2022.
- NRCS and Forest Service will evaluate proposals and announce selected projects in late fall of 2022.
- Priorities include but are not limited to:
 - Reduction of Wildfire risk
 - Increase forest workforce capacity
 - Benefits to historically underserved communities and climate mitigation and adaptation efforts

 - FL received 2 proposals for Classic RCPP
 - Proposal evaluation team review completed
 - National award notification expected August 2022

Local Working Group (LWG) Overview

- What is the intent of the LWG?
 - Provide recommendations on local natural resource priorities and criteria for NRCS conservation activities and programs.
 - Usually chaired by the local Soil and Water Conservation District (SWCD)
- LWG responsibilities include:
 - Public involvement and the conservation needs assessment led by the Soil and Water Conservation Districts
 - Hold public meetings (LWG) to develop a local conservation action plan
 - LWG recommendations are submitted to the State Technical Committee

Local Working Group (LWG) Process

July: NRCS releases LWG Questionnaire

September: meeting details are posted to AFCD and NRCS website

October-November: LWGs meet and submit questionnaires to NRCS

January State Technical Committee: NRCS reports summary of LWG responses

June State Technical Committee: NRCS reports final decisions

LWG Summary Report

- Based on lessons learned and input gathered from the State Technical Committee, LWGs and NRCS staff, the following are the actions NRCS FL will take to incorporate LWG feedback at the local level:
 - Each NRCS field office (FO) will have a funding pool they can use to address local priorities and resource concerns.
 - FOs will review the LWG recommendations on an annual basis.
 - FOs will develop ranking criteria for the individual funding pool that take into consideration recommendations from the LWGs.

NRCS FLORIDA EASEMENTS

Agricultural Land Easements:

- NRCS provides financial assistance to eligible partners for purchasing Agricultural Easements to keep land in agriculture and protect grazing uses.
- Eligible partners include Indian tribes, state and local governments & non-governmental organizations that have farmland or grassland protection programs.

• Wetland Reserve Easements:

• NRCS provides technical and financial assistance directly to private landowners and Indian tribes to restore, protect, and enhance wetlands through the purchase of a wetland reserve easement.

Regional Conservation Partnership Program:

- RCPP is now a standalone program with its own funding
- Provides financial assistance through Partnership agreements
- Funds Agricultural, Wetland, Forestland & Other Conservation Easement type acquisition / restoration.

NRCS FLORIDA EASEMENTS

- FY2022 ACEP WRE Allocation: \$19,935,190
 - \$14,635,190 for Enrollment & Restoration
 - 4 WRE applications approved for funding
 - \$5,300,000 for Stewardship
 - Management of nearly 200,000 acres of WRE/WRP easements
- FY2022-2023 ACEP WRE Enrollment
 - 11 WRE applications needing \$41,176,436
 - FY 2023 WRE Rollover Applications
 - FY 2023 WRE Easement Compensation 80% rate
 - FY 2023 Ranking Approval

- RCPP Easements
 - FB2014: 5 HFRP enrolled easements pending acquisition.
 - FB2018: 3 RCPP projects approved pending enrollment


Challenges Facing Northwest Florida Population Growth




Challenges Facing Northwest Florida Transportation Systems for a Growing Population


Our Biologists



- Both programs work with willing partners to conserve, manage, and restore habitat by providing technical and financial assistance to landowners and producers complimenting Farm Bill conservation programs with an emphasis on listed species recovery and the avoidance of additional species listings.
- The latest version of the At-Risk Species Finder, a tool that provides the public and state partners a way to find At-Risk species and help inform management decisions, was recently released. This finder also provides opportunities to explore other information on these species and to promote collaborative pro-active conservation.
- PFW covers private lands (non-federal or state) / CP covers public and private lands.
- PFW projects have a minimum 10-year commitment ensuring work is maintained.
- CP can provide both technical and financial assistance for third-party land acquisitions to protect habitat.


