- Pab txog 2,178 sq.ft. Pab txog \$3.76 rau 1 sq.ft. Lwm haiv neeg tsawg xwmli Hmoob yuav tau txog \$4.51 rau 1 sq.ft.

## Seasonal High Tunnels (Hoop Houses)



### Extend Your Growing Season

The Environmental Quality Incentives Program (EQIP), can help pay for the construction of High Tunnels (hoop houses.)

#### Benefits of High Tunnels:

- Extend the growing season for fresh market vegetables, and other crops increasing yields and profitability
- Improve water quality by reducing pesticide use

#### Eligibility:

- Land must be in cropland and you must have control of the land for the length of the contract (4 years)

#### Requirements:

- Size is limited to 2,178 sq.ft. Payment rate \$3.76/sq.ft. for general and \$34.51 for historically underserved groups
- Plantings directly into the soil or in raised beds of on-site soils
- NO planting in pots, on racks or growing media
- The tunnel frame needs to be at least 6 feet in height
- UV resistant cover - at a minimum, a 6 mil greenhouse grade polyethylene
- Electricity and heating is allowed
- Irrigation systems allowed where needed
- Structure can be moved annually to a new location or cover crops, mulches can be used
- Producer repairs damages to maintain structure for the 4-year lifespan of the practice

## Seasonal High Tunnels (Hoop Houses)



### Extend Your Growing Season

The Environmental Quality Incentives Program (EQIP), can help pay for the construction of High Tunnels (hoop houses.)

#### Benefits of High Tunnels:

- Extend the growing season for fresh market vegetables, and other crops increasing yields and profitability
- Improve water quality by reducing pesticide use

#### Eligibility:

- Land must be in cropland and you must have control of the land for the length of the contract (4 years)

#### Requirements:

- Size is limited to 2,178 sq.ft. Payment rate \$3.76/sq.ft. for general and \$4.51 for historically underserved groups
- Plantings directly into the soil or in raised beds of on-site soils
- NO planting in pots, on racks or growing media
- The tunnel frame needs to be at least 6 feet in height
- UV resistant cover - at a minimum, a 6 mil greenhouse grade polyethylene
- Electricity and heating is allowed
- Irrigation systems allowed where needed
- Structure can be moved annually to a new location or cover crops, mulches can be used
- Producer repairs damages to maintain structure for the 4-year lifespan of the practice
