### MASSACHUSETTS STATE TECHNICAL ADVISORY COMMITTEE MEETING

July 23, 2024 9:00am - 12:00 pm Meeting Held Virtually

## Welcome and Opening Remarks - Dan Wright, NRCS/USDA

The meeting was called to order at 9:00am by Dan Wright, Massachusetts State Conservationist. Dan welcomed everyone and requested attendees enter their Name, Agency, and Title into the Chat.

Minutes from the November 21, 2023, meeting of the State Technical Advisory Committee was accepted.

Dan briefly mentioned planning happening at both the state and national levels. He met with the National Leadership Team to discuss planning, getting feedback and how we can improve processes and systems. Agency policy updates are being explored. An action team at the national level has been created to focus on policy updates.

As an agency, we are exploring changes both on the Financial Assistance Programs Division (FAPD) and the Easements Program Division (EPD). Working on streamlining processes to make them more expeditious.

- Regional Conservation Partnership Program (RCPP) MA has received more applications this fiscal year than we have ever received. The national estimated ASK for funding this year is \$1.5 billion dollars. As an agency we are looking to see how we can better capture RCPP in the future.
- Equity We need to work on outreach and making our programs accessible to all, both at the state and national levels.

MA has been selected to have an Urban Ag office set up in the city of Boston. We're working on trying to get a mobile field office (i.e. Van) that can travel to any producer in the state. There is still a look at the national level of trying to establish a brick-and-mortar location in Boston. NRCS and the Farm Service Agency (FSA) will be meeting in the first full week of August to discuss Urban Ag offices and the next steps are for them.

Aggression and Prejudice - Notify leadership if you hear of any aggressive and prejudice behavior whether at outreach events, farm visits, etc. We want to make sure our staff, our partners, and our producers are heard. We want to be able to provide the services in whatever way feels safest and best for us and them.

Staffing – As close to 100% capacity as we have ever been. More staff than we have had in 15-20 years with 65-66 Full-Time Federal Employees and 24-25 Partner Employees.

- Project Management Comprehensive Nutrient Management plans and contract management in general, statewide.

National Water Quality Initiative (NWQI) Program - We currently have four Projects in progress.

Source Water Protection (SWP) Areas - Specifically looked at for drinking water.

- Nationally, a state can only have 20% of the state included in a SWP area. Being a densely populated, small state with a lot of drinking water impairments, MA was granted a waiver to add additional percentages of SWP areas. Currently, 29.7% of the state is in a SWP area.
- Applicants located in SWP area with water resource concerns receive a 90% cost share rate.

# Forestry and Wildlife Subcommittee - Patrick Conlin, MassWildlife, Habitat Biologist

Patrick provided updates from the most recent subcommittee meeting.

- Met 6/27/24
- 20 Attendees representing private sector, private nonprofit, state, and federal.
- Introduced Mike Barry, Forester for NRCS MA
  - Mike Barry has been working toward qualifications to allow him to plan prescribed fire practices in MA.
- Discussed how prescribed fire practices offered don't meet up with the needs of the state and how it would be helpful to have a variety of scenarios to account for the variation in burning different habitats (i.e. Grassland vs. Woodland).
- Exploring ideas for proposed practices for the NRCS Conservation Innovation Grant (CIG).
- Looking into the Umbrella agreement offered by U.S. Fish and Wildlife Service in partnership with entities like NRCS to provide additional planning and technical support, including securing compliance, which is a hurdle for several practices.
- Discussed wanting to propose Forest Stand Improvement, Brush Management, and Successional Habitat Management as Priority Resource Concern practices for FY2025.



## Soil Health Committee - Kate Parsons, NRCS/USDA, and Caro Roszell, AFT

Kate provided updates from the most recent Soil Health Subcommittee Meeting:

- Met 10/26/23
- Approx. 15 Attendees representing farmers, consultants, MACD, UMASS, CISA, AFT, and DCR
- Shared experiences and thoughts on soil health challenges.
- Lincoln Fishman, farmer and soil health consultant, presented on his project on a white clover living
  mulch in annual cropping system. No till system and trying to have perennial cover and dealing with the
  issue of getting cover crops established later in the fall.
- Expressed interest in more technical information on compost and manure and the differences.
- One of the producers expressed interest in bringing in an expert soil health producer to present at a field day.
- NRCS in coordination with AFT held a webinar on Soil Carbon Amendment
  - The Soil Carbon Amendment practice helps pay for biochar, compost, and other carbonaceous amendments to improve soil quality and other purposes.
  - Webinar was held 4/18/24
  - 127 registrants, 66 Attendees
  - Arthur Siller and Olivia Golden, Soil Health Specialists at UMASS, presented on the compost side of the Soil Carbon Amendment
  - Debbie Aller, Cornell Soil Health Specialist, presented on biochar.
- Future Work
  - Review soil health related program ranking questions and provided feedback as applicable or needed.
  - Host a field day for producers to learn more about healthy soil structure Tentatively Fall 2024

### Easement Subcommittee - Chair, Jamie Pottern, AFT

- Have been meeting quarterly with 20-35 attendees. Primarily local and regional Land Trust staff, NRCS, and local municipalities.
- Last met on 4/10/24
- 22 Attendees
- Received updates from Rita Thibodeau and her Easement team and MDAR about funding and encouraging folks to get applications in.
- Introduced new AFT staff member, Kathleen Doherty.
  - Came from CT Farmland Trust.
  - Extensive experience with ACEP-ALE projects.
  - Her role is to provide one-on-one technical support to partners on the ground.
  - Serves as support to the NRCS MA Easement team.
  - Kathleen ran through a brief overview of FLI initiative.
- Ran through case studies.
- Brainstorming session on potential improvements and changes to some of the Easements programs in the future.

# Program Manager - Martha Craig, Cape Cod Conservation District (CCCD)

Cape Cod Water Resources Restoration Project (CCWRRP)

- Developed by NRCS and approved by Congress in 2009.
- Developed to address environmental degradation of water quality and fish and wildlife habitat.
- Will have long-term, beneficial effects on restoring the water resources and ecosystems along the coastal areas of Cape Cod.
- Agricultural benefits improve water quality entering bivalve aquaculture farms.
  - Improve water quality to over 7,300 ac of shellfish growing areas with the installation of stormwater treatment systems.
  - Restore/Improve access to 4,200 ac of spawning, nursery, and juvenile habitat for anadromous fish through installation and/or repair of aquatic organism passages (fish ladders).
  - Restore 1,500 ac of degraded salt marsh.
- To reach the goals of the plan, NRCS contracted with the CCCD to review the CCWRRP Watershed Plan and suggest updates. The CCCD, through consultation with the towns, updated the list of projects that would meet the Plan goals over the next 4-5 years.



- Based on the new project list, NRCS received \$42 million in FY22 for 25 projects and \$22.5 million for FY23. NRCS has also provided funding support for the CCCD to help manage these projects. Currently, 4 full-time staff and multiple technical experts.

### About the State Technical Committee


