# STATE TECHNICAL COMMITTEE MEETING

# 9:06am Welcome and greetings - Nate Goodrich, NRCS ASTC-Partnerships

- we will continue to have 2 virtual meetings and 2 face-to-face meetings (with no virtual options) each year
- everyone introduces themselves
- apologies for Joe Aull, FSA, we would have had him give a speech virtually but we are suffering technical difficulties and cannot get any sound out of our equipment (even with NRCS State Engineer trouble shooting for us)

# 9:12am Welcome and Greetings - Scott Edwards, NRSC State Conservationist

- hand out is from the NRCS Fly In visit to Congressional members, shows State Cost Share with SWCD-we are double the funding this year over last, and next year we will see triple that funding from last year, due to Inflation Reduction Act alone. There is still no Farm Bill, but we did receive our full funding budget in April of 2024
- Little Otter Creek Reservoir and Roy Blunt Reservoir have current year funding, but until new Farm Bill is passed, we have no new funding for watershed projects in Missouri
- NRCS has been suffering from connectivity issues on the computers that handle all of our contracts and applications, so in January we had to extend all of our deadlines and timelines for the FY, and we are now behind where we normally are in terms of obligations made
- ACT NOW, added to move funding out the door quicker, and Missouri has been stressing Nutrient Management and a 5 county pilot for pond cleanouts and other water projects outside of the Farm Bill. With this program we must publish our thresholds and how much total funding is available. \$6.5 million into over 14,000 acres.
- Urban Ag programs, already started in STL but starting soon in KC, have been wildly successful. We are still trying to nail down an office location for the KC Urban Ag program, but until then, they are working out of the Liberty, MO field office.
- We have been funding 30 to 35% of all applications in the past, but with the new IRA, we look to fund up to 50% of all applications.
- Questions to get help from our partners on lobbying for projects (like the decrease in watershed projects), is there a way that NRCS can pass that information along to others who can lobby on our behalf? We can continue to provide technical information to our partners.

#### 9:32am FSA – Drew Walters standing in for Joe Aull

- not much new for FSA's programs, paid out over a million dollars in drought relief last year on 185 applications
- short notice to State Technical Committee for Grasslands CRP State Zone, only about 10 days to create proposal and submit, but FSA did get one generated and submitted

# 9:39am ACEP and Watershed Program Update – Chris Hamilton, NRCS ASTC-Water Resources & Easements

- currently performing an area wide market analysis, due in July
- full appraisals being made across the state instead of being region restricted, \$5,000 still rate cap per proposal
- see briefing slides for the total ACEP FY24 allocation

- PL 83-566 Watershed Program, to include Little Otter Creek and Roy Blunt Reservoirs, very popular with Missouri producers, but funding has come and gone over the years, causing environmental impact statements to expire and have to be re-done before moving forward on many long term projects. See briefing slides for the priorities in this program here in Missouri. Total of 26 projects in Missouri in various phases of completion (PIFR, Pending Planning Authorization, Planning, Design, and Construction), covering many purposes, including Water Supply, Flooding, Recreation, and Agriculture Water Management.
  - Questions Little Otter Creek, on time and on budget? On budget, yes. Expected to be completed in Spring 2025, which is a little behind schedule. PL-566 program, USACE said they looked at a watershed project in Kansas, how is that impacting the Missouri River and KC District? Is NRCS looking at building another reservoir in the KC area? NRCS does work with USACE closely, and will continue to work together on watershed projects in Missouri. We are looking at projects across all of Missouri, including the KC area, but we need to do over the environmental impact statements on all of them.

- Guidance Document is coming soon for CPS 336

# 11:12am Outreach, Technical Assistance, and Conservation Innovation Grant Proposal Input – Nate Goodrich, NRCS ASTC-Partnerships

- we need our producers/partners to provide input for priorities in FY25 for our grants and agreements send any thoughts or ideas on this to Nate Goodrich, <u>nate.goodrich@usda.gov</u>
- 3 areas annually in Missouri Outreach and Education (\$1.5 million), Technical Assistance (\$2.5 million), and Conservation Innovation Grants (\$500k, out of EQIP funding)
- getting a new Forester on staff to help with Forest Management Planning and Practice Implementation
  - o suggested:
    - open up more informational/training conferences to all producers, not just urban ag
    - keep reaching out to folks we aren't already working with, and be wary of "climate smart practices" wording
    - don't leave outreach to industry
    - does NRCS work with virtual fencing? Not currently, but we are having discussions, and CIGs are still open for FY24 as well as going into FY25.
