FY22 Conservation Innovation Grants (CIG)

Iowa NRCS selected four State CIGs in FY22. These grants help develop the tools, technologies, and strategies to support next-generation conservation efforts on working lands and develop market-based solutions to resource challenges. Grantees match the CIG investment at least one to one.

Black Hawk SWCD: This project will create an innovative approach for conducting outreach among historically underserved customers and identify a potentially replicable process for discerning their unique needs, strengths, and challenges. A culturally competent outreach plan will be developed to support historically underserved customers. (\$60,884)

Iowa Valley RC&D: The recipient will leverage its production experience and community connections to enhance awareness of intensive no-till organic vegetable production, and expand no-till production to allow GROW (a hunger relief and educational farm program) to improve soil, train farmers in innovative methods, and inform consumers. (\$74,170)

Practical Farmers of Iowa: This project will promote invertebrate habitat practices such as beetle banks and insectary strips intentionally designed to benefit farm production for urban and semi-urban specialty crop farms, and it plans to engage historically underserved farmers to meet project objectives. The overarching goal is to accelerate the adoption of urban and suburban beneficial insect habitat across Iowa. (\$99,993)

Practical Farmers of Iowa: PFI and its producers will explore the viability of reducing tillage in organic production systems (aka "organic no-till") in Iowa. Specifically, CIG funds will support 20 on-farm trials that will investigate organic no-till practices on row-crop and vegetable farms; trial results and producer experiences will be shared through several events and written and video outreach pieces. The main goal of the project is to explore the viability of reducing or eliminating tillage as a natural resource conservation practice for organic production systems in Iowa. (\$99,773)

FY22 Iowa Partners in Conservation

IPC funds are used to help support Iowa NRCS mission areas and increase partner staff in local field offices.

Iowa Organic Association (IOA): In partnership with the Organic Agronomy Training Service (OATS), IOA will coordinate four annual organic technical training for NRCS personnel. The goal is to help increase technical capacity, knowledge, and use of resources to meet the needs of Iowa's growing organic community. OATS will also serve our NRCS Field Offices with on-demand assistance to answer organic farming

related questions; and IOA will provide quarterly organic updates for distribution to NRCS staff. (\$70,090)

Iowa State University (ISU): This project will develop a Forest-to-Farm network to streamline the denitrifying bioreactor woodchip supply chain to support statewide efforts in increasing conservation adoption of the practice. On-farm trials will demonstrate the performance of conventional and alternative woodchips for the bioreactors. (\$336,106)

Other Conservation Activities

Sand County Foundation
Iowa NRCS signed a five-year agreement with the Sand County Foundation to produce five high-quality videos, showcasing the conservation efforts of the Iowa Leopold Conservation Award winners. (\$15,000)

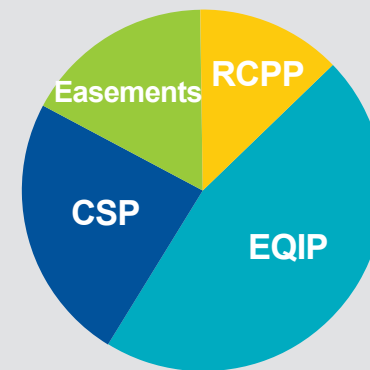

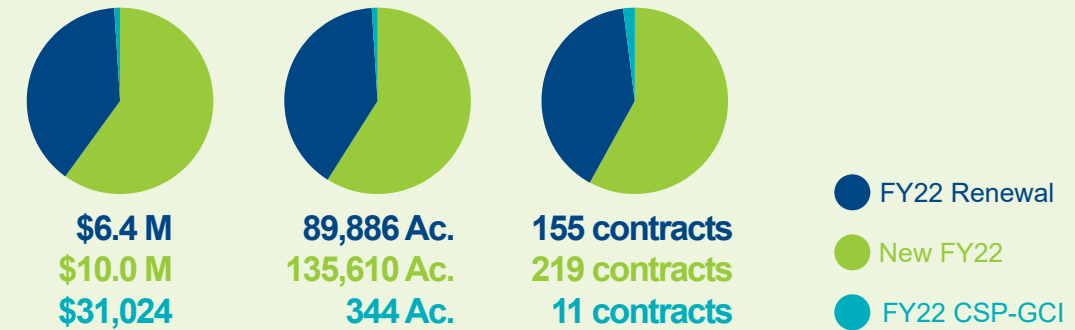

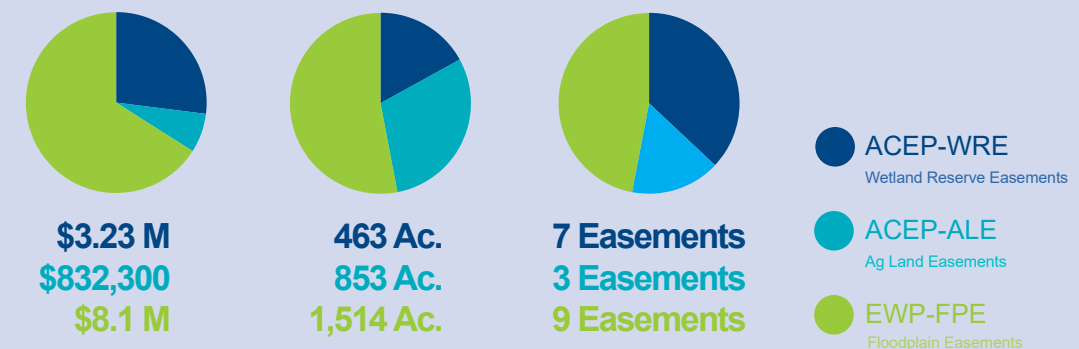
