# Somerset County Soil and Water Conservation District 2024 Local Working Group (LWG) Meeting Minutes

Thursday, January 18, 2024, from 1:40 –3:43 PM held in-person as well as via Zoom Video Call

Jenn Hebert, Somerset SWCD Executive Director, called the meeting to order and thanked attendees for their participation. Jenn asked attendees to introduce themselves, stating their name and organization/department/town of residence or land ownership. All participants were emailed on January 4<sup>th</sup> and reminded on January 16<sup>th</sup> or immediately upon their registration if after this date, with a packet that included: meeting agenda, 2023 LWG Meeting Minutes, summary sheets on NRCS programs, 2024 NRCS State Funding Allocations and a Zoom virtual meeting link.

Jenn discussed what the Local Working Group (LWG) is, the role of the group in this meeting, and how participants can ask questions to the presenter or group. Jenn asked the group if anyone had any questions or comments regarding the 2023 LWG Meeting Minutes. David Bernard requested that the minutes be revised to define acronyms contained within the document. *Motion made by Joe Dembeck to revise 2023 minutes to define all acronyms in the document. Seconded by Ben Koehler. Motion passed.* Once Jenn makes the approved revisions the meeting minutes from the 2023 LWG will be finalized.

Alexis Clune (NRCS District Conservationist)

- Reviewed the historical funding levels and category allocations (both local and state funding pools) and explained the FY2024 fund allocations (state pools) in detail to the group.
- Explained the new funding initiative "ACT NOW" which allows NRCS to immediately approve and obligate a ranked application in a designated ranking pool when an eligible application meets or exceeds a State determined minimum ranking score will apply to all planning applications. She shared the stats on current sign up for FY24 in Somerset.
- Aquatic Restoration projects in addition to standard Environmental Quality Incentives Program (EQIP) will now also be available in Somerset to be funded through a Regional Conservation Partnership Program (RCPP) component of EQIP.
- New this year is the Beginning Farmer initiative will switch focus from Soil Health to Ag Waste.
- Inflation Reduction Act (IRA) provided additional funding for conservation practices. Maine NRCS received \$904,000 for CSP and \$12,321,000 for EQIP for FY24 under IRA
- A copy of Alexis' slide presentation is available upon request.

A lively discussion regarding the recent excessive rainfall events and other climate change impacts ensued. It was noted by Peter Belloff that the US Secretary of Agriculture is aware that priorities are changing, and things will evolve as the climate science progresses.

Alexis then turned the groups focus on soliciting comments for FY 2025 allocation.

After reviewing a snapshot of FY23 applications received and funded. Discussion followed, including:

Joe Dembeck asked if Alexis knows how much funding the county will receive. To date, it is still unknown.

Joe Roy asked if IRA funding will include forestry practices this year. Last year it was disappointing how few were funded. Alexis indicated that the funding is greatly increased this year. A second application period is likely to occur once the current round closes in March.

It is important to the group that forestry practices are funded in this county. Joe Dembeck, Joe Roy both indicated that it has been discouraging in the past that so many applications have not been funded.

Joe Dembeck commented that a statewide pool of funds for Ag Waste may help more contracts get approved. Ag Waste projects are extremely expensive.

Joe Dembeck suggested that the percentages stay the same as last year:

Ag Waste – 70% Forestry – 23% Crop – 6% Pasture – 1%

Discussion ensued. Alexis Clune then asked the entire group about their support for this proposal. All were in favor, but it was noted that the applications for cropland should be monitored to ensure that 6% is enough in the future.

No comments or discussion.

## Forestry Category Local Questions

A discussion about forest access roads and erosion/water quality problems ensued. Joe Roy indicated that Timber Stand Improvement needs to continue to be a priority. Tim Hewitt commented that the economics of the timber industry is top priority for landowners. Ultimately the group reached consensus to change the local ranking questions to:

- 1) Does this plan include Forest Stand Improvement (666)?
  - Yes  $\rightarrow$  100 points
- 2) Will the practices in this application be used to treat non-native invasive species?
  - Yes  $\rightarrow$  25 points
- 3) If the applicant has had an NRCS contract previously awarded, did the contract fall behind schedule for reasons within the applicant's control? Answer No if no previous contracts.
  - Yes  $\rightarrow$  negative 25 points
- 4) \* Will the practices in this application include timber stand improvement in forest stands with average diameter of less than 5 inches?
  - Yes  $\rightarrow$  25 points
- 5) \* Will this application address erosion in the forestland?
  - Yes  $\rightarrow$  25 points
