Draft Plan-EA Notice of Availability (NOA)



Project Information

The U.S. Department of Agriculture's Natural Resources Conservation Service (NRCS), American Fork City, Lehi City, and Saratoga Springs City announce the availability of the Draft Watershed Plan and Environmental Assessment (Plan-EA) for the American Fork-Dry Creek Watershed and Flood Prevention Operations Project (Project). The Project proposes flood prevention improvements at the following eight (8) locations within the American Fork-Dry Creek Watershed in Utah County, Utah:

Site 1 (300 North in American Fork City) – Improve embankments, construct new wing walls & a new concrete apron. Armor with gabions/riprap.

Site 2 (100 North/200 East in American Fork City) – Reconstruct embankments, create a new transition into the existing box culvert. Armor embankments with gabions/riprap for erosion control.

Site 3 (200 South in American Fork City) – Replace energy dissipation baffle blocks with riprap on downstream banks. Improve channel slope & width.

Site 4 (400 South in American Fork City) – Widen the upstream channel and raise the riverbanks using gabions.

Site 5 (Upper Dry Creek in Lehi City) – Replace existing culverts to provide more downstream (DS) capacity. Install gabion baskets.

Site 6 (Upper Waste Ditch in Lehi City) – Replace existing structures to create more capacity.

Site 7 (Waste Ditch at Willow Park in Lehi City) – Excavate & expand unimproved sections of Waste Ditch. Replace undersized box culvert. Improve DS channel for more capacity.

Site 8 (Lower Dry Creek in Lehi & Saratoga Springs City) – Channel clearing and gabion lining sections of Dry Creek.

An evaluation of potential project alternatives and associated environmental impacts has been documented in the form of a Draft Plan-EA. NRCS (lead federal agency) and American Fork City (Project sponsor), will hold a public meeting to provide information about the proposed Project and to collect comments on the Draft Plan-EA.
