
Hi Charles,

I am working on an EA document with the NRCS and the City of Saratoga Springs. As part of the EA, I need to identify permits that may be required for proposed activities. Alternatives for the EA proposed modification to some of the ephemeral drainages upstream of the City of Saratoga Springs. Based on the definition of a "natural stream" below for requirements of stream alternation permits, the ephemeral channels do not appear to meet the definition.

A natural stream is any natural waterway that receives enough water to develop an ecosystem that differs from the surrounding upland environment. This is most easily determined by observing vegetation changes. Canals, ditches, or other man-made channels are not considered natural streams.

The ephemeral channels in question do not have water in them for most of the year and only flow after a large precipitation event. The vegetation along the channels consist of upland species and no vegetation changes or riparian ecosystems are present. Pictures of the channels are provided below for reference as well as a map of the channels.

Based on the ephemeral nature of the channels and lack of riparian ecosystems, I assume these channels would not require a stream alteration permit. However, your confirmation would be greatly appreciated.

Hi Bobbi,

I took a closer look at the project area on gis and it looks like there isn't much aquatic habitat within the project area. If this is a correct assessment then I don't feel that there is any risk to the aquatic species listed. Most of the species listed are thought to be extirpated in the Utah Lake area, but if there is any shoreline habitat included in the project, the June Sucker and a few of the mollusks listed might be worth keeping. If not then I don't think they need to be included.

Sounds good, thanks Kaitlyn. We include the following standard language in our EAs for migratory bird and state sensitive species. However, it will still be important to note in the EA which SGCN could be present or should be considered based on Utah Division of Wildlife Resource (UDWR) feedback. I will wait to hear back from you next week on any SGCN or recommendations.

If construction activities occur during migratory bird breeding/nesting periods, the Project area (and surrounding habitats) would be surveyed by a qualified biologist for active nests no more than 5 days prior to the commencement of work. If active nests were found during surveys, spatial buffers would be established around such in coordination with USFWS and NRCS. Construction activities within the buffer areas would be prohibited until a qualified biologist confirmed that all nests are no longer active. Direct short-term impacts of this alternative to migratory birds and associated habitat would be negligible based on implementation of avoidance/minimization measures, preconstruction surveys, restoration of disturbed areas, and abundant suitable habitat in the surrounding area.

Areas of disturbance would be surveyed by a qualified biologist prior to the commencement of work for state SGCN. If SGCN were found during surveys, UDWR would be notified and applicable conservation measures implemented in coordination with UDWR.



1.0 Introduction

The United States Department of Agriculture Natural Resources Conservation Service (NRCS), in cooperation with the project sponsors (Saratoga Springs City and Utah Department of Agricultural and Food), is proposing improvements within the Saratoga Springs Watershed located in Utah County, Utah. Measures are being proposed to address watershed improvements to reduce potential flooding to properties in Saratoga Springs. In addition to the Clay Pits area improvements, Saratoga Springs City requested that the recent Knolls Fire burn boundary also be included in the EA-Plan scope.

The project is partially funded through the NRCS Watershed Protection and Flood Prevention Act (Public Law [PL] 83-566), which authorizes funding to help urban and rural communities protect, improve, and develop land resources in watersheds of up to 250,000 acres. NRCS, as the lead federal agency, has initiated NEPA analysis in the form of a Supplemental Watershed Plan and Environmental Assessment (Plan-EA) to analyze impacts to the environment from project actions. The Plan-EA will comply with the Council on Environmental Quality's (CEQ's) regulations at 40 CFR Parts 1500-1508 which require an evaluation of potential environmental impacts associated with federal project and actions. The Plan-EA will be composed of the elements listed below.

- Alternatives analysis of potential options to meet the general purposes of PL 83-566, and the defined purpose and need of the project.
- Detailed analysis of resources that may be affected for each of the alternatives analyzed in detailed study that may satisfy the purpose and need for the project.
- Identification of potential avoidance, minimization, and mitigation measures to reduce or eliminate potential impacts.
- A plan of public participation and agency consultation and coordination throughout development of the Plan-EA.

The participation of the public/agencies/organizations is a vital component of the NEPA process and development of project alternatives so that those who are interested in or potentially affected by proposed project alternatives have an opportunity to share their concerns and provide input regarding the Plan-EA during the initial stages of the planning process. Scoping is the first phase of the public involvement process, and this report documents the scoping process conducted for this project.

1.1 Purpose and Need

The general purposes of NRCS Watershed Protection and Flood Prevention Action (PL 83-566) include:

- Preventing damage from erosion, floodwater, and sediment.
- Furthering the conservation, development, utilization, and disposal of water.
- Furthering the conservation and proper utilization of land.

The project-specific purpose and need will be developed as the planning advances. Project sponsors and public/agencies/organizations have expressed a need for watershed improvements to reduce potential flooding to properties in Saratoga Springs Watershed. In late June and the first week of July 2020, the Knolls Fire burned an area located directly south of the original project area. Saratoga Springs City requested that the Plan-EA be expanded to include the boundary of the Knolls Fire and the areas downstream that may be negatively affected by debris flows and erosions due to the fire.

1.2 Scoping Goals and Objectives

Scoping is used to identify the public, stakeholder, and government agency resource concerns for the project and potential obstacles/controversy/opposition, and to begin to identify proposed alternatives based on the input received. It is important to involve a diverse group of public/agency/organization participants. During the scoping process and throughout the development of the Plan-EA, ongoing communication will be maintained with stakeholders, agencies, organizations, tribes, and the public. Education about the environmental review process and each party's role will be provided to all participating parties. Public participation activities will be evaluated for effectiveness on a continual basis and use the most effective techniques throughout the NEPA process. Scoping activities involving outreach and meetings and the results of scoping are documented to ensure NEPA, CEQ, and NRCS scoping requirements have been met.

2.0 Scoping Process Summary

This section summarizes the scoping activities performed and outreach conducted for the proposed project.

2.1 Scoping Announcement and Open Comment Period Schedule

- The following dates outline the milestones for the scoping announcement and activities that occurred in preparation for the scoping comment period. The scoping comment period **opened on June 30, 2020, and closed on August 3, 2020**. March 12, 2020: Scoping announcement was mailed to landowners, the public, and agencies.

- June 26, 2020: Scoping announcement was mailed to landowners, the public, and agencies.
- June 26, 2020: Scoping flyers were emailed to Saratoga Springs City for posting in the Saratoga Springs City Hall and Saratoga Springs Public Works Building.
- June 30, 2020: Scoping announcement was mailed to five tribes.
- July 6, 2020: Scoping notice was published in The Daily Herald.
- July 13, 2020: Scoping notice was published in The Daily Herald.
- June 30, 2020 (Open Comment Period)
- June 26, 2020: Scoping notice and public meeting details were posted to the NRCS project website
- July 14, 2020: Virtual scoping meeting was held online via GoToMeeting. The meeting was recorded and made available for review on the NRCS project website.
- August 3, 2020 (Close Comment Period)

2.2 Notice

Materials were developed to announce the public scoping meeting and consisted of a scoping notice, flyer, and newspaper notices. These materials identified the proposed project site, announced the open comment period, listed the scoping meeting details, and requested public participation and input. Contact information for submittal of comments was provided in all postings along with the open date for the comment period. The materials were distributed and posted as listed below. Copies of the scoping notice, flyer, and newspaper notices are included in Appendix A.

- A scoping notice was prepared and mailed to 43 agencies/organizations/public on June 26, 2020.
- A tribal scoping letter was prepared and mailed to five tribes on June 30, 2020.
- Scoping flyers were emailed on June 26, 2020 to NRCS, Saratoga Springs City Hall, and the Saratoga Springs Public Works building.

- The scoping notice, project status, and scoping meeting information was posted on the NRCS project website on June 26, 2020, for the duration of the scoping comment period. The website is located at:

In addition to the notice materials above, the sponsors also provided additional measures to help announce the scoping meeting details. Saratoga Springs City announced the meeting details on their website.

2.3 Meetings

One scoping meeting was held during the scoping comment period. The virtual meeting was held July 14, 2020, 10:00 to 11:00 am, online via Zoom. The meeting was recorded and made available for review on the NRCS project website. The meeting presented the overall project and Plan-EA process. The scoping meeting presentation is included in Appendix B.

Participants of the scoping meetings were invited to submit comments in writing by mail, fax, phone, or e-mail during the scoping comment period. Attendance at the meeting was verified by a verbal roll call at the beginning of the scoping meeting. A list of attendees is in Appendix B.

2.4 Mailing List

A public and agency/organization mailing list was prepared by NRCS, the sponsors, and Bowen Collins and Associates, to inform them about the scoping process and scoping meetings for the project. A total of 43 mailings were sent to the public and agency/organizations.

A tribal mailing list was prepared by NRCS and a formal scoping letter was sent out to five tribes. The tribal scoping letters are included in Appendix A.

3.0 Comments

3.1 Public Meeting

The virtual public scoping meeting was conducted on July 14, 2020. There was 16 people attending the Zoom meeting including public/agencies/organizations and project team members. Attendance roll was called at the beginning of the meeting. The meeting attendance sheet is provided in Appendix B.

King Félix opts out of MLB season

Former Cy Young Award winner Félix Hernández has joined the list of major leaguers opting out of the 2020 season due to the coronavirus pandemic, at least temporarily ending the 34-year-old's bid to revive his career.

Stars Christian Yelich of the Milwaukee Brewers and Jose Altuve of the Houston Astros said Sunday they plan to play the 60-game season scheduled to start later this month. Reliever Sean Doolittle, who helped Washington win the World Series last year, plans to play but says that if he feels uncomfortable, he'll opt out. He also wondered if the United States has done enough to combat the pandemic to deserve a this season." return to sports.

As baseball prepares to start ing whether to play. its season in less than three weeks while the coronavirus now trying to make decisions continues to ravage the U.S., there is growing unease in many clubhouses. Even Mike Trout's mother weighed in on Twitter, urging Americans to wear masks as the reigning AL MVP considers his options for the season.

In Oakland, two projected members of the Athletics' starting rotation, ace Mike Fiers and Jesus Luzardo, were not on the field for a second straight day of the reboot of spring training because of what manager Bob Melvin called a "pending" issue without elaborating, aside from saying it's not injury-related.

Fiers was the whistleblower of the Houston Astros' sign-stealing scandal who pitched his second career no-hitter last season. He and Luzardo were workout partners in Florida during the offseason and quarantine period.

The A's, who have lost the AL wild-card game the last two seasons, are not confirming positive coronavirus tests.

Oakland was forced to push back its first full-squad workout because intake testing results for position players were not yet available following the July 4 holiday. The team expects to practice as a full unit Monday.

Atlanta Braves manager Brian Snitker said Hernández decided to opt out after he participated in workouts on Friday and Saturday at Truist Park. The decision came a day after Snitker announced that four-time All-Star first baseman Freddie Freeman, premier reliever Will Smith and two other Atlanta players tested positive for the virus.

Hernández, a six-time All-Star in 15 seasons with Seattle who won the 2010 ALCy Young Award, needed a fresh start following his worst season. King Félix signed a one-year minor league deal with the defending NL East champion Braves and made a strong early impression in spring training before the pandemic delayed the season.

Minutes after Nationals manager Dave Martinez said two players out of 60 tested were positive for the virus, Doolittle lamented not having his test results backfrom Friday and implored baseball to "clean this up."

The 33-year-old said the Nationals still haven't received the respirator masks they were told were coming.

"It's a little bit disorganized," Doolittle said. "We're not getting tests back in time. They still haven't sent us the PPE. We're supposed to have N95 masks, stuff like that, gowns, gloves. We're supposed to have that stuff, we don't have that stuff. Those are the things it's safe enough for us to continue

Doolittle said he's still debat-

"There's a lot of players right that might be participating in camp that aren't 100 percent comfortable with where things are at right now," Doolittle said. "I'm planning on playing, but if at any point I start to feel unsafe, if it starts to take a toll on my mental health with all these things that we have to worry about and just kind of this cloud of uncertainty hanging over everything, then I'll opt out."

Doolittle also implored fans to take care of themselves and attempt to stop the spread of COVID-19 to make sure baseball and other sports can re-

"Sports are like the reward of a functional society, and we're just like trying to bring it back even though we've taken none of the steps to flatten the curve or whatever you want to say," he said, "We did flatten the curve for a little bit, but we didn't use that time to do anything productive. We just opened back up for Memorial Day. We decided we're done with it.

"If there aren't sports, it's going to be because people are not wearing masks because the response to this has been so politicized. We need help from the general public. If they want to watch baseball, please wear a mask, social distance, keep washing your hands."

Yelich, the NL MVP in 2018, said he never thought of opting out but will support any player who does.

"For myself, it was an easy call," he said Sunday, "Guys are all in different boats. If you choose to opt out or if we ever had anybody who chose to opt out, I would fully support that Debbie, tweeted a picture of her decision and understand where they were coming from."

Altuve, the 2017 AL MVP, has two daughters at home, including one who was born this summer.

Although he had concerns about returning to play, he said: "I asked our doctors and almost everybody how high-risk my baby and my wife could be because (the baby) is so young. play.

Daniels said he didn't plan to announce if the team has any more positive tests.

Pittsburgh manager Derek Shelton said outfielder Socrates Brito and pitcher Blake Cederlind tested positive for the coronavirus and allowed their names to be released. Shelton indicated there are other players on the club who have tested positive but have not granted the team permission to announce the diagnosis.

Philadelphia ace Aaron Nola is among the seven Phillies players who haven't reported. The team is not revealing who is on the COVID-19 list. Seven players have tested positive, including the players who forced the shutdown of the team's spring training complex a few weeks ago.

The Chicago White Sox said two players tested positive and are asymptomatic. They are isolated in Chicago.

Morikawa clutch in finish to win Workday Open

DUBLIN, Ohio - Collin Morikawa figured his tournament was over if he didn't make a 5-foot par putt on the 15th hole at Muirfield Village.

He couldn't have imagined all the fun was just starting.

Still three shots behind Justin

The only dull moment Sunday at the Workday Charity Open was the end, when Morikawa took two putts for par from just inside 10 feet to beat Thomas on the third playoff hole and win for the second time in his career.

"Amazing," Morikawa said when asked how he would sum up the day to someone who only saw the result. That covered a lot of territory.

Morikawa never looked like the winner until it was over.

Thomas had 10 straight one-putt greens, the last one a 25-foot eagle putt on the par-5 15th for the threeshot lead with three holes to play. And while he made two bogevs for a 69 that allowed for a playoff, he had reason to think it was over when he made a 50-foot birdie putt from the back of the 18th green.

Thomas said. "Percentages would say that it heavily is close to being that way. ... I just tried to keep my head down and think he's going to make it, but hoping he's not, selfishly, but he did."



Hamilton wins Styrian GP ahead of teammate Bottas

SPIELBERG, Austria -Lewis Hamilton won the Styrian Grand Prix from pole position on Sunday to clinch an 85th career win and move within six of Michael Schum-

acher's Formula One record. Most of Schumacher's wins were during a dominant spell with Ferrari, but his old team is struggling badly. For the second time in the past four races, Charles Leclerc and Sebastian Vettel crashed into

each other and went out. on the podium he raised a fore the national anthem.

clenched right fist. Hamilton's record-extending 89th career pole on a rainbest in extreme conditions, and finished fourth ahead of race. but during the race he was hardly challenged as he finished a sizeable 13.7 seconds ahead of Mercedes teammate Valtteri Bottas and 33.7 ahead of Red Bull's Max Verstappen.

Because of social distancing amid the coronavirus pandemic, the drivers on the podium had their trophies delivered by a remote controlled device.

"What a weird year but (it's) great to be back driving with this kind of performance. The team did a fantastic job, it was just for me to bring it home," said Hamilton, who finished fourth last week after a time penalty. "Difficult weekend last weekend but this was a great step forward."

Despite the sizeable margin of Hamilton's win, Bottas maintains he can challenge for the F1 title. He leads in points 43-37.

"I have no reason to doubt any of my ability or skills. I know what I'm capable of," the Finnish driver said. "I really feel some improvements in my driving since last year that's why I'm confident it will be a good battle for the cham-

"When Valtteri tried to pass me I tried to make it a bit more difficult," Verstappen said. "The podium is good but



To Whom it May Concern:

On Tuesday, July 14th I attended a virtual public scoping meeting for the Saratoga Springs Watershed Plan-EA. The presentation addressed the need to prevent flooding in an area known as the Clay Pits area. This area includes drainage from the Lott Canyon and Burnt Canyon drainages of the Lake Mountains, just south of Tickville Gulch. This is the only area that was originally identified for improvements within the proposed Watershed Plan-EA.

In late June and the first week of July, a fire was started called the Knolls Fire. This fire affected a large area of the Lake Mountains located directly south of the original project area. The Knolls Fire resulted in a burn area of approximately 1,200 acres. The fire caused damaged to BLM, SITLA, and privately owned land. The City would like to request that the Saratoga Springs Watershed Plan-EA be expanded to include the boundary of the Knolls Fire and the areas downstream that may be negatively affected by debris flows and erosion as a result of the fire.

Figure 1 shows the general extents of the burn area.
