Details for 2025 Soil Survey Data Refresh

The U.S. Department of Agriculture's Natural Resources Conservation Service (NRCS) refreshes the publicly available soil survey database once a year. This Annual Soils Refresh (ASR) introduces new soil data and interpretations and updates existing soil data and interpretations. The ASR also ensures all official soil data adhere to the same standards.

The official soil survey database was refreshed on October 1, 2025. The Soil and Plant Science Division made the data available to the public through Web Soil Survey, Soil Data Access, and SSURGO Portal.

The list below highlights some of the major changes to the official soil survey database in 2025.

- Tabular and spatial data refreshed for all soil survey areas
- 3,379 soil survey areas published
- 41,974,803 acres of new soil data added
- 116,727 new soil polygons added
- 2,227 new map units added
- 20,321 new soil components added
- 75.702 new soil horizons added
- 119 national soil interpretations published
