MRBI Bundle #4- Cropland with Water Bodies, No Till

Conservation Practices: (340) Cover Crop; (329) Residue and Tillage Management, No Till; (590) Nutrient Management; and (595) Integrated Pest Management plus an option for (390) Riparian Herbaceous Cover, (391) Riparian Forest Buffer, or (393) Filter Strip

APPLICABLE LAND USE: Crop (annual)

RESOURCE CONCERNS ADDRESSED: Soil Erosion, Soil Quality Degradation, and Water Quality Degradation

PRACTICE LIFE SPAN: 1 year

Enhancement Description

Addresses the following resource concerns on annual crop for soil erosion, soil quality degradation, and water quality degradation.

By implementing these enhancements together a synergy is achieved that should result in more conservation benefits than might be expected from the individual enhancements. Applicants that choose to implement this bundle of enhancements will receive an increase in ranking and payments.

Criteria

- All of the component enhancements in the required group must be implemented and one additional component enhancements must be adopted from the table below. However, if an applicant has already adopted one or more component enhancements within a bundle, the applicant may schedule the bundle as long as the applicant is newly adopting the majority (more than 50 percent) of the component enhancements within the bundle.



CONSERVATION STEWARDSHIP PROGRAM

- Applicants may choose to adopt a bundle on any portion of the agricultural operation and will be required to install component enhancements on all applicable acres where the bundle is adopted.
- The bundle is scheduled in the year in which all component enhancements in the bundle are applied but no later than the third fiscal year of the contract. However, the bundle once adopted may continue to be implemented in all subsequent years through the end of the contract.

Documentation Requirements

Follow the documentation requirements in the respective enhancement job sheets to document the implementation of each component enhancement in the bundle. In addition, document the planned amount, fields, applied amount and the year each component enhancement in the bundle will be applied:
