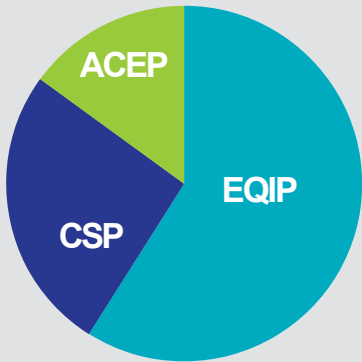

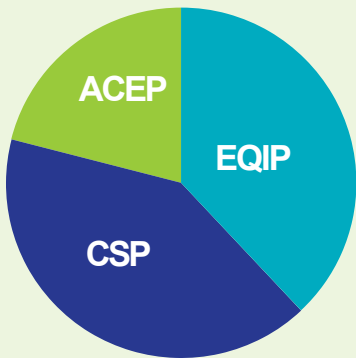

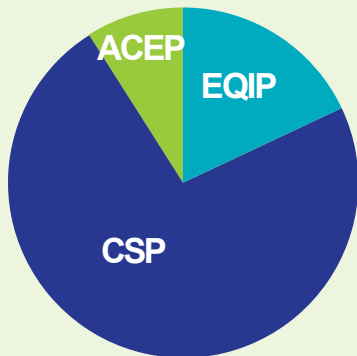

FY19 Iowa Partners in Conservation Projects

Iowa NRCS provided \$1 million to three Partners in Conservation projects in FY19. These funds will be used to help support Iowa NRCS mission areas and increase partner staff in local field offices.

Iowa DNR Technical Assistance Partnership Partner: Iowa Department of Natural Resources

Project will expand and accelerate delivery of direct technical assistance to landowners. (\$495,540)

Charles City Watershed Project Partner: City of Charles City

Project will address soil erosion nutrient runoff and resilience to extreme weather events through direct technical assistance to watershed landowners. (\$435,000)

Conservation Cropping System Demonstration Project Partner: Iowa Soybean Association

Project will promote soil health and increase adoption of conservation cropping systems by providing direct technical assistance to landowners. (\$250,341)
