Looking Ahead: Staffing and Structure

During FY18, NRCS and FSA will hire 2,400 employees (1,100 NRCS positions). Because USDA's priority is to focus on customer service, 90 percent of these positions will be directed to the field and state level. These positions will be advertised in a series of phases.

So what does this mean to Iowa NRCS? Currently our agency is wrapping up the second hiring phase, making a total of 33 new positions. And we are currently working to develop a list of 75 additional positions, to be hired before the end of FY18.

Even with additional staff, we know that Iowa NRCS needs to look at efficiencies to address future workloads and meet customer service expectations.

We are just beginning the process of working with our partners and a facilitator to develop alternatives for field office and staffing structure.

Finally, I'm very pleased to announce that Kurt Simon will return to duty here in Iowa on July 30. After he returns, he will likely pull some double duty, serving as an advisor to Under Secretary Bill Northey until our agency has a new chief in place. But he is excited to get back home at the end of July.

ONEUSDA: CONDUCTS OUTREACH AT LGBTQ YOUTH CONFERENCE

For the 13th consecutive year, bus loads of students, teachers, parents and LGBTQ youth supporters attended the Governor's Conference on LGBTQ Youth in Des Moines. Held at the Iowa Events Center, more than 1,500 people came from all corners of the state to attend workshops and hear a terrific slate of speakers.

Conference topics included LGBT civil rights laws, bullying prevention strategies, homelessness and human trafficking among LGBT youth, and social justice advocacy. FARMER FEUD: HELP DECIDE WHAT THE "SURVEY SAYS"

BANDING TOGETHER: SUMMER INTERNS HELP WITH DNR PROJECT

This month a group of five summer interns assisted the Iowa DNR Missouri River Wildlife Management Unit with a state-wide banding project to monitor the migrating population of Canada Geese. NRCS wetland easements provide important habitat for migrating birds, like Canada Geese.

The group banded more than 100 Canada Geese, and also identified a Cackling Goose, which typically is found in arctic climates. They also identified five previously-banded geese. DNR staff will use their band info to track the migration of each goose. When any of the banded geese are harvested or found dead of natural causes, their band number is reported back to the DNR and data is added to the study.

Boats were used to safely herd the geese to the shore at the Lewis and Clark State Park campground, and then guided to a catch pen by staff walking slowly and calmly towards them---similar to herding livestock.

Staff (carefully) determined the gender of each goose which were then banded by the DNR biologist. After they were "escorted" back to the shoreline for a safe release.

Several interns, Charolette Rielly (Onawa) and Isabella Faris (Sioux City), got some extra training when they volunteered to backup the boat trailers and load the boats. District Conservationist Jackie Kragel reported both efforts were very successful. :) Other interns included Dylan Rague (Carroll), Natasha Klocke (Sergeant Bluff) and Alyssa Scott (Onawa).

The birds were much larger and stronger than many of the interns expected, especially when handling them while trying to determine their gender. While the experience would be award enough, Kragel shared that each intern received special participation awards: goose poop!

MEET LIAM MCVEY: IOWA'S YOUNGEST SOIL HEALTH EXPERT

Liam McVey, currently a sixth grader at Fayette Elementary school, recently participated in a Practical Farmers of Iowa field day on the Don Elsbernd farm near Postville. Liam is the son of Kelsi Solheim, Farm Bill Specialist in the West Union Field Office.

One of Elsbernd's long term goals is to increase soil organic matter which in turn will increase his profitability. Liam's experiment, which showed the benefits of healthy high organic matter soil, illustrated this point perfectly by simulating a drought on high and low organic matter soils.

Liam began working on his experiment as a fifth grader after talking to NRCS Area Agronomist Neil Sass about soil health. During the field day Neil and Liam discussed the experiment using an interview style with Liam answering questions about his methods, materials, hypothesis, etc. He answered them all clearly and accurately, and then afterwards he took any and all unprompted questions from the audience of 40 farmers. According to Neil, Liam was calm, cool, collected, and very confident. And he stole the show!

Kevin shared the highlights of the three phases of his career: working directly with farmers and contractors to add conservation to the landscape; investing in individual employees and help them grow professionally; and hopefully in this third phase of his career he wants to focus on doing more things to provide technically help for field office staff.

In His Free Time: Kevin enjoys using his free time to travel to Minneapolis to visit his 14-month old grandson.

Family: Kevin and his wife Beth, who live in Ames, have been married since 1984. They have two adult children: a daughter who lives in Minnesota with her husband and child; and a son, who recently married and lives in Seattle.

You can drive your personal vehicle for government business, even if it displays a political bumper sticker.

FALSE. Personal or government-owned vehicles used for official Government business must not display political bumper stickers.

CELEBRATING 25 YEARS OF EASEMENTS: AT BIG WALL LAKE & DOWS

More than 1,500 Iowa landowners have enrolled about 186,000 wetland acres into conservation easements since 1993. Iowa NRCS celebrated 25 years of easements at a special event on June 15 in Dows.

Iowa leads the nation in the number of conservation easements with 1,620, about 65 percent of these remain in private ownership. Nationally, private landowners have enrolled more than 22,000 easements, covering more than

4.4 million acres through NRCS easement programs.

Originally, the event was to be held at the Big Wall Lake wetland complex. But was relocated because of high rainfall.
